WellPoint appreciates the Centers for Medicare & Medicaid Services' ongoing work to dramatically expand access to Medicaid coverage under the Affordable Care Act. The agency has demonstrated a willingness to help states meet their Medicaid expansion goals which has resulted in greater access to care for millions of the nation's most vulnerable citizens. WellPoint is writing to express our support for the 1115 waiver application, submitted by the Indiana Department of Family and Social Services Administration designed to expand its Medicaid program. By approving the Healthy Indiana Plan 2.0 or "HIP 2.0" CMS will enable an additional 350,000 medically underserved individuals to access the primary care and preventive services needed to lead healthy lives.

WellPoint has a unique relationship with the state of Indiana. WellPoint's headquarters is in Indianapolis, and we have strong ties to the community. WellPoint and its affiliated health plan, Anthem Blue Cross and Blue Shield (Anthem) proudly serves more than 240,000 Hoosiers on Medicaid.
